VAERS Reporting Requirements for COVID-19 Vaccines

Healthcare providers who administer COVID-19 vaccines are **required** to report the following to VAERS:

- Serious AEs regardless of whether the reporter thinks the vaccine caused the AE. Serious AEs per FDA are defined as:
 - **Death**
 - A life-threatening AE
 - ...
- ...
- **Cases of COVID-19 that result in** hospitalization or **death**

Explanation of Death Certificate fields

Death Certificates have two types of “Cause of Death” entries

- 1) **Narrative fields** in which certifiers write textual narratives
 - CODIA = Immediate cause of death
 - CODIB, CODIC, CODID = Underlying causes of death
 - CONDII = Conditions contributing to death
- 2) **Coded fields** in which certifiers use internationally recognized **ICD-10 codes** to represent each cause in the **narrative fields**
 - Examples: **Y590 = “Viral vaccines”**; **T881 = “Other complications following immunization, not elsewhere classified”**; **U071 = “COVID-19”**; I269 = “Pulmonary embolism without mention of acute cor pulmonale”

ICD-10 codes are how causes are tracked by public health orgs

SUMMARY of Pages 13-19

Brianna McCarthy, 30yo, died April 2021

- STROKE (from VAERS & Death Certificate)

Eden MacDonald, 17yo, died June 2021

- STROKE (from VAERS & Death Certificate)

Holly Hodgdon, 42yo, died Sept 2021 (Holly's brother Dan Earley, 37yo, died June 2021 unexpectedly)

- INTERNAL BLEEDING (from local anecdote; but Death Certificate states U071 "COVID-19" as cause of death)

Charles Casella, 48yo, died Nov 2021

- Died in his sleep < 24hrs after vaccination (from personal contact; but Death Certificate states U071 "COVID-19")

Abigail Fitzgerald, 20yo, died Dec 2021

- MYOCARDITIS (from news, obituary & Death Certificate)

Cassidy Baracka, 7yo, died Jan 2022

- GI shutdown - minutes to onset, days to painful death (from news, obituary, VAERS record & Death Certificate)

Preston Settles, 15yo, died Feb 2022

- CARDIOMYOPATHY (prior heart condition) **Was he vaccinated? If so, when? And if so, how long would he have lived with his heart condition but for vaccination?**

Access to MIIS database is needed to prove vaccination dates

Summary of Pages 97-98 Overdose Fraud

Pattern of poor death certificate completion

24 death certificates contain both X42 & U071 and no other codes

X42 = “Accidental poisoning by and exposure to narcotics and psychodysleptics [hallucinogens], not elsewhere classified”

U071 = “COVID-19”

A positive test is not a “cause of death” and it is fraud to put “U071” or “COVID-19” as a cause of death on a death certificate when it had nothing to do with the causal chain leading to death.

- Year 2022
- SFN_NUMBER 822
- CODIA = “ACUTE COCAINE AND FENTANYL INTOXICATION”
- CONDII = “SARS-COV-2 POSITIVE”

U071 should NOT appear on this death certificate, but it does.

Summary of Pages 91-96 Dr. Chanda

Pattern of poor death certificate completion

Jyotirmay Chanda, Lic# 226711, Physician in charge of patient's care

CODIA is the "Immediate Cause of Death" field.

Dr. Chanda certified **25 total death certificates** in 2020, 2021, and 2022 through June.

19 of the 25 certificates have almost the same wording in the CODIA field "ACUTE RESPIRATORY FAILURE"

An expert Medical Examiner pointed out that this is lazy behavior probably by a physician who does not know the rules of completing a death certificate. This practice obfuscates the root cause of death.

For example, here are other causes Dr. Chanda certified as underlying that should have been CODIA instead of "ACUTE RESPIRATORY FAILURE":

- Congestive heart failure - qty SIX
- Acute renal failure - qty FIVE
- Acute cerebrovascular accident - qty TWO
- Hemorrhagic stroke - qty ONE

How many of these death certificates were recently C19-vaccinated people whose circulatory system was attacked?

These death certificates are not properly filled out. There is a clear pattern of unacceptable behavior.

Only inspection of the MIIS and medical charts can show the truth.

Summary Pages 99-105

Medical Examiner Dr. Robert Welton

Pattern of fraud or error in death certificates

Dr. Welton is a professional Medical Examiner certifying ~400 death certificates per year.

Summary

- **28 Total “U071” records in-period certified by Welton**
- 10 involved pneumonia, 3 involved COPD, 1 involved asthma
- 12 had no reference to respiratory ICD-10 codes (“J” codes)
- 4 involved drug overdoses
 - **Example:** “ACUTE FENTANYL INTOXICATION IN A PERSON WITH A SARS-COV-2 (COVID-19) POSITIVE CULTURE”
- 6 involved “CARDIAC DYSRHYTHMIA” and only 1 of those had pneumonia. 5 others had no respiratory issues.
- 6 involved “IMPACT INJURY”
- 1 is a 13yo boy “COMPLICATIONS OF MULTI-ORGAN FAILURE IN A CHILD IN THE SETTING OF RECENT SARS-COV-2 POSITIVITY”

These are not mistakes. They are likely intentional fraud. Y590 and T881 are never used by this Medical Examiner. COVID-19 U071 is added when clearly the decedent died from a fentanyl overdose, impact injury, or heart arrhythmia.

All Dr. Welton’s death certificates should be inspected and amended to reflect the true causes of death and an investigation should ensue.

Summary of Pages 106-110

Medical Examiner Dr. Janice Grivetti

Pattern of fraud in death certificates

Dr. Grivetti is a professional Medical Examiner certifying ~400 death certificates per year.

Summary

- **21 Total “U071” records in-period certified by Grivetti**
- Only 1 involved pneumonia and 1 involved COPD
- The other 19 had no reference to respiratory ICD-10 codes (“J” codes)
- 3 involved drug overdoses “ACUTE FENTANYL INTOXICATION”
- 1 involved “ALZHEIMER'S DISEASE; RIGHT HIP FRACTURE; HYPERTENSIVE AND ATHEROSCLEROTIC CARDIOVASCULAR DISEASE; DIABETES MELLITUS, COVID-19”
- 1 involved “HYPERTENSIVE AND ATHEROSCLEROTIC CARDIOVASCULAR DISEASE AND HEART FAILURE”
- 1 involved “BLUNT FORCE TRAUMA OF TORSO”
- 4 involved U071 COVID-19 and no other causes (not acceptable; no one dies from COVID-19 alone without some other cause)
- 5 involved COVID-19 and OBESITY and no other cause

These are not mistakes. They are intentional fraud. Y590 and T881 are never used by this Medical Examiner. COVID-19 U071 is added when clearly the decedent died from a fentanyl overdose, blunt force trauma, or heart disease.

All Dr. Grivetti’s death certificates should be inspected and amended to reflect true causes and an investigation should ensue.

Summary of Pages 111-118 Speculative Records Ages 20-29

Pattern of fraud in death certificates

Search: 2022 death certificates, ages 20-29, that have a U071 code

Summary

- **13 Total “U071”, ages 20-29, year 2022**
- **TWO involved “X4” drug overdoses**
- **TWO involved “N179” sudden kidney failure**
- **ONE involved brain swelling**
- **ONE involved arrhythmia**
- **ONE involved myopericarditis**
- **SEVERAL involved questionable U071 as related to actual cause**

All of these records should be inspected for fraud or error. This is vitally important for the public interest.

The public deserves to know if what they fear is the result of fraud and if what they inject to allay the fear is the actual kill mechanism.

Many of these look like other COVID-19 vaccine deaths previously documented.

Are people risking their children’s lives thinking they are doing the right thing? The death certificates depict the opposite of what the government is saying. When the vaccine kills a 7yo girl and the Medical Examiner tells the public she died from COVID-19 and the government tells parents to be afraid and vaccinate their children, how many more children then die?

Summary of Pages 119-122 Speculative Records ages 5-19

Pattern of fraud in death certificates

Search: 2022 death certificates, ages 5-19, that have U071 code

Summary (6 Total “U071” records in 2022 ages 5-19 and U071)

- Healthy children these ages do not have a hard time with COVID-19

There are only 6 records. All of these records should be inspected for fraud or error.

People see that 7yo Cassidy died from COVID-19.

So they get their sons and daughters vaccinated out of fear.

But 7yo Cassidy reacted in abdominal pain in minutes and died in 5 days.

Few know that because of the double fraud (omission and commission) on this record.

- MIIS and medical chart access would yield many more Massachusetts vaccine deaths. How many more? 5,000?




A craniotomy was performed the following Saturday as a last ditch effort to relieve the unrelenting pressure in her brain. The craniotomy was able to reduce the pressure but it was too late. There was no longer any brain activity and my cousin's daughter was removed from life support after they were able to say their goodbyes. The medical examiner will be examining her brain to attempt to find a cause but that report may take 6 months.</p>

But for the purposeful omission of C19 vaccine, by medical examiners, as causes of death, in prior death certificates, danger would have been known, coercion to vaccinate would have ebbed, and this 30yo daughter, friend, and teacher would be alive today.

Same sex and age

Both VAERS and death certificate clearly show same person

VAERS report was made the day before she died. Thus, no death date on VAERS report. DAYS and WEEKS vaccine to onset to death.

Died 7 weeks after 30yo woman SFN_NUM 19578 = same hemorrhage. Dose1 headaches so bad she went to PCP multiple times until it resolved. Then, Dose2 C19 vaccine killed her in a brutally painful way.

But for the fraudulent omission committed in SFN_NUM 19578, this 17yo girl might be alive today. The ME on this death certificate committed same fraud of omission, leaving more to subsequently die.

This death certificate has no corresponding VAERS report. **This is the death certificate of a wife and mother of two children.**

On reason and belief Plaintiff included this record because the cause of death is inconsistent with obituary and other writings.

No one dies from simply COVID-19 only.

The decedent's brother posted on social media in June 2021 that he was worried about the decedent's internal bleeding. The brother died "unexpectedly and peacefully" a week or two after his social media post and did not make it to the decedent's funeral in September when she died. **The parents lost both children at 37yo and 42yo within 3 months.**

Medical charts and MIIS records can provide missing information for stronger correlation. If the medical charts indicate onset of hemorrhaging in the decedent in June 2021, there is clearly fraud of omission of Y590 and T881 on death certificates AND fraud of commission by adding U071 when she did not die from COVID-19. Only inspection of MIIS and medical chart records can exonerate medical examiners

This death certificate has no corresponding VAERS report.

This case was verbally communicated to Plaintiff by a friend of the family.

It was stated that decedent did not want to receive the C19 vaccine, that Bose Corporation was going to terminate his employment if he did not get the vaccination, and that the decedent relented on the last day possible and got the vaccination. It was stated that the decedent was found dead in bed the next morning after vaccination.

Plaintiff was given name, date of death, town of residence, age, and sex verbally. All checked out correctly when Plaintiff looked up the death certificate. Plaintiff assumed other details were correct as well.

A review of the decedents' MIIS record can provide the date of vaccination and determine causal attribution of the C19 vaccine.

If this 48yo man died within 24 hours of vaccination and ME knew, but omitted Y590 and T881, then fraud of omission on a public record has again been committed like the pattern shown in prior and subsequent records of this EXHIBIT.

Also, the fraud of commission of adding U071 when that was not a cause of death also applies in this case.

While he had a known history of seizures, he had no clear trigger for these seizures; including that his valproic acid level was therapeutic (83.0 mcg/mL) at time of presentation. He had, however, received the Johnson & Johnson vaccine on March 12 before having what in hindsight appeared to be repeated seizures between March 18-21; he had a more significant one on March 21 that hospitalized him. This time frame appears consistent with the reported cases of central venous sinus thrombosis associated with the Johnson & Johnson vaccine. Equally, he was taking apixaban at that point in time and his PLT (173) / INR (1.1) / PTT (36.6) at time of presentation were all normal and stable. He did have an elevated ProBNP (552.0) at presentation; nasopharyngeal swab was negative for COVID / Influenza A/B / RSV and non-contrast head CT did not show any clear new abnormalities. His only D-dimer was obtained on March 23 and was 226. He did not have a CT angiogram or venogram. Overall the link between the vaccine and pt. seizures is not definite. At the same time, the similarity with the reported cases has led to me wanting to report it in case of the possible link. VAERS record and death certificate have several conditions and causes in common. Clearly, these records are from the same person.

ONE DAY to onset of symptoms from C19 vaccination date. Died THREE days after vaccination date.

COVID-19 “U071” is blamed as a cause of death, though it was a “prior covid infection”. That indicates he recovered.

Clearly, this person had a miserable existence with spinal stenosis, breathing on and off a ventilator well before this incident, and generally poor and painful health.

However, this is clear evidence that the C19 vaccine sent the man to his death in only a THREE DAYS. He is noted as having had a prior COVID-19 infection. Natural immunity is known to be better than vax immunity. Why would anyone stick a needle in his harm?

MIIS should be inspected for vax date proximity to illness. If the VAERS report is correct, the ME had fraudulently omitted C19 vaccine as a cause of death and has omitted using codes Y590 and T881.

After the records of C19 vaccine listed as causes of death in the narrative fields, but not in the ICD-10 codes (except the one solitary entry), there are a few death certificates that note the “unvaccinated” status of decedents.

Medical examiners should be asked why they chose to write “unvaccinated” on so few death certificates and can we assume all others are “vaccinated”?

MIIS records and patient charts for these decedents should be reviewed to correlate these deaths to vaccination dates.

Considering the intracranial hemorrhage, cardiac arrhythmia, thrombocytopenia, pulmonary embolism, sepsis, myocarditis, and other circulatory system related deaths common in vaccination deaths from earlier records shown herein, it is in the public interest to correlate MIIS records to death certificates.

Medical Examiner Dedrick wrote the **ONLY** one of the ~420,000 death certificates from 2015 through June 2022 to use the codes **Y590** “Viral vaccines” or **T881** “Other complications following immunization, not elsewhere classified”; and she used both of them.

She should be commended for being the only one to actually perform her duty of care in public records.

She wrote “**idiopathic**” relative to **thrombocytopenia**.

Idiopathy means:

1. A disease of unknown origin or cause.
2. A primary disease arising spontaneously with no apparent external cause.
3. In pathology, an idiopathic character of disease; a morbid state or condition not preceded and occasioned by any other disease.

Thus, she is likely intending to convey that there is no other known cause of this thrombocytopenia than the C19 vaccine.

Doctor Worden noted in the CONDII field that “vaccination was given 5 days before death and she developed fever and mental status changes shortly after getting it.”

Medical Examiner Elin mentioned that the decedent received the C19 vaccine.

Given the history of DVT and other thromboses, this decedent should have been screened out from receiving the C19 vaccine. Some would consider it medical malpractice and dangerous to her life.

Interestingly the hypertension and atherosclerotic heart disease were listed as the immediate cause of death and the interstitial lung disease was listed as an underlying cause. The C19 vaccine is known to cause hypertension and heart issues.

Given the way this is written, MIIS and medical charts should be inspected to determine temporal proximity of vaccination to date of onset of symptoms and death.

Examples

- 5 involve “ACUTE ... RENAL FAILURE”

- 3 involve sepsis or septic shock (another one actually is in the CODIA field)
